- ✓ Booth spaces are offered for free to local creatives based on a first-come basis, as long as the booth is theme related.
- ✓ FAC asks for a donation based on sales for the day, to keep these events free or low cost for our creative makers.
- ✓ There is limited electricity available for an additional cost of \$5.00.
- ✓ You must provide your own tables, chairs, etc.
- ✓ Locations will be pre-assigned. If you have a preference, please note that preference in your application. Requests will be considered on a first come first serve basis.
- ✓ Vendors are responsible for leaving their space clean and free of any debris.
- ✓ Vendor applications for future events may be denied if space is not left clean and/or the vendor leaves the event early.
- ✓ The event will be held rain or shine.
